# Food is Medicine Advocacy Day in Washington, D.C. & State Policy Update



#### 1) Federal Policy

Last week, ROC was on Capitol Hill for the **Food is Medicine Advocacy Day**, joining PHI's Center for Wellness and Nutrition and allies from the National Produce Prescription Collaborative, including Wholesome Wave. We championed the power of food as medicine and produce prescription programs in building a healthier, more resilient food system.

While in Washington D.C., we shared the impact of the freeze on key USDA programs, including the Partnerships for Climate-Smart Commodities Grants. In meetings with California delegation members on the Senate and House Agriculture Committees, we made it clear: these programs are essential, and these investments are critical to farmers, ranchers and agricultural communities.

#### 2) State Policy

#### ROC Co-sponsors AB 411 - The C.A.T.T.L.E Act

The California legislative year is well underway, and Roots of Change is actively engaging on a number of priority bills, including our proud co-sponsorship of AB 411, the 'Caring About The Terrain, Livestock, and Ecosystems (C.A.T.T.L.E) Act', authored by Assembly Member Diane Papan (AD-21). This bill supports a healthier and sustainable agriculture by allowing farmers and ranchers to compost livestock mortalities, improving soil health, reducing greenhouse gas emissions, and supporting climate resilience.
